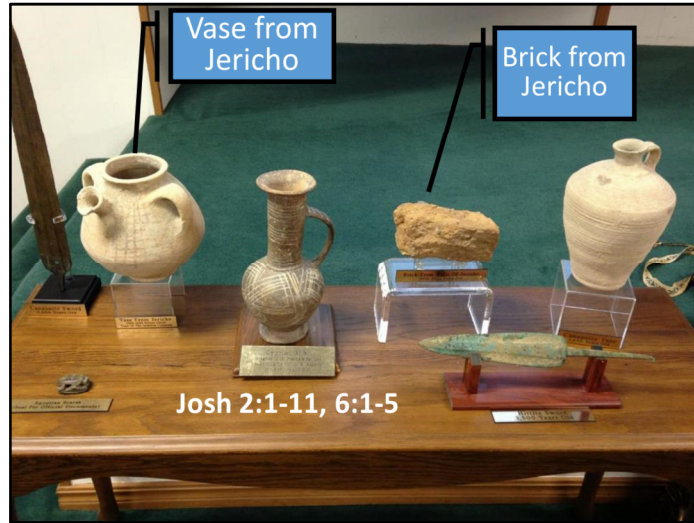
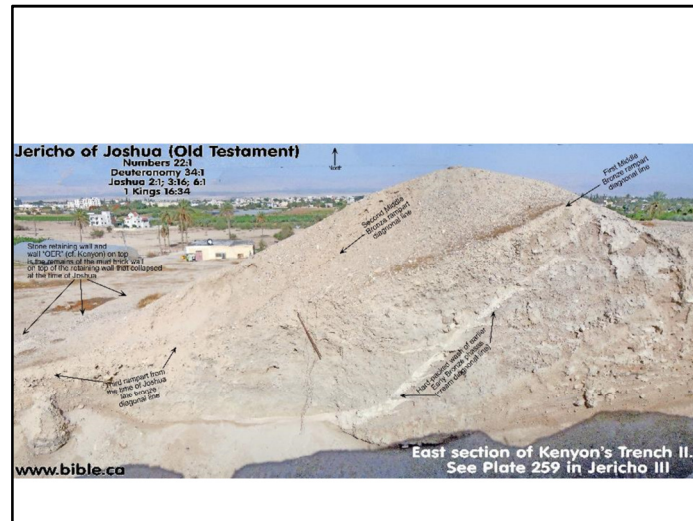


## **Evidences from Don Patton's Personal Artifacts**

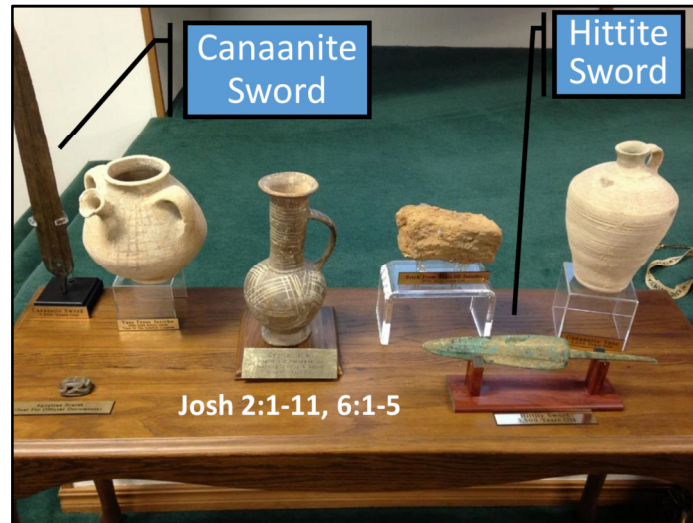
Discuss the nature of objections to the Old Testament; atheist state just a book of stories; fabrications; they refuse to use any information from the Bible as factual.

Discuss the nature of Archeological evidences; weakness of theories vs. strength of Biblical text ect.

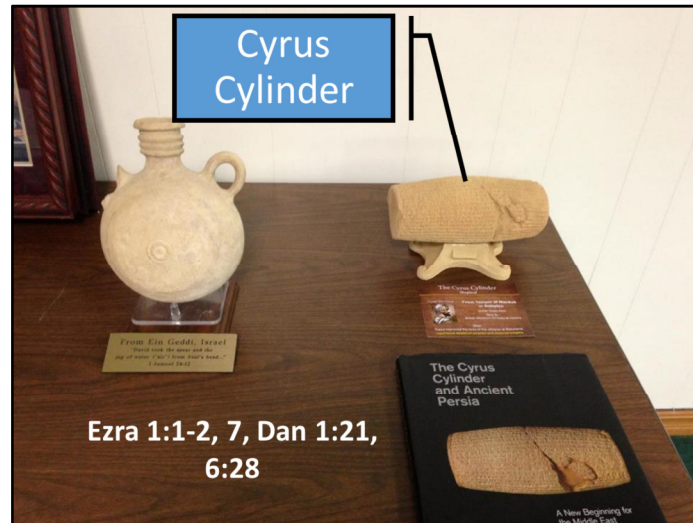




Excavations in the land can be as much as 10-30' below grade. When one culture was destroyed, the next would build on top of it.

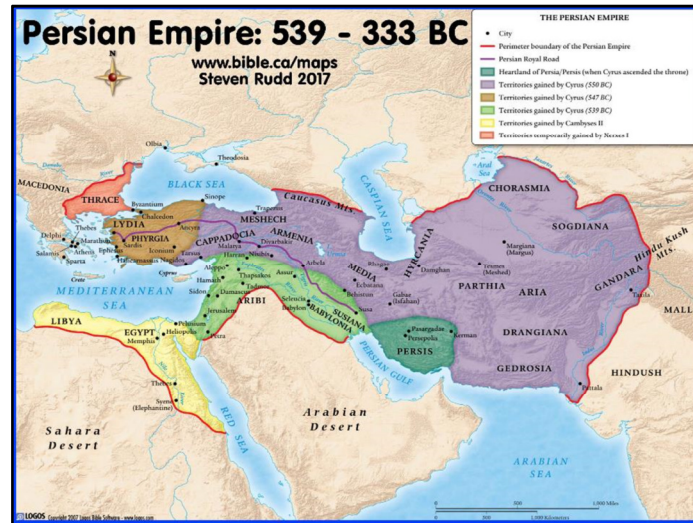


Canaanite & Hittite nations were from Genealogy of Ham

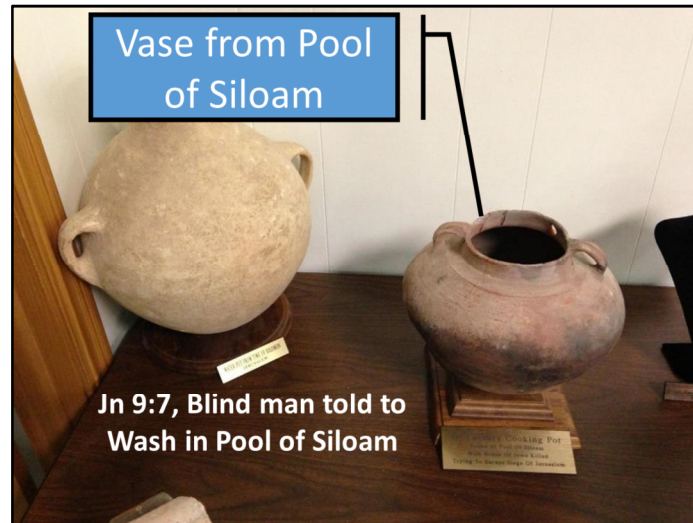


Wikipedia: It is an ancient clay cylinder, now broken into several pieces, on which is written a declaration in [Akkadian cuneiform script](#) in the name of [Persia's Achaemenid](#) king [Cyrus the Great](#).<sup>[2][3]</sup> It dates from the 6th century BC and was discovered in the ruins of [Babylon](#) in [Mesopotamia](#) (modern [Iraq](#)) in 1879. ... It was created and used as a [foundation deposit](#) following the [Persian conquest](#) of [Babylon](#) in 539 BC, when the [Neo-Babylonian Empire](#) was invaded by Cyrus and incorporated into his [Persian Empire](#). “the text refers to the restoration of cult sanctuaries and repatriation of deported peoples.”

#### Introduction From Bible.ca

1. "pool of Siloam is found 3 times in the Bible: Neh 3:15 "Pool of Shelah"; Is 8:6, "waters of Shiloah"; Jn 9:7, "pool of Siloam"
2. The Hebrew word "Siloam" means "sent". Pool of the Sent. This is interesting because Jesus "Sent" the blind man to this pool to be healed.
3. Josephus often references the pool of Siloam. He said it was located at the end "Valley of the Cheesemongers" or the Tyropoeon Valley (Josephus, Wars 5.4.1). He also said it was outside the city wall (Josephus, Wars 5.9.4) at a place where the old wall bent to the east (towards the rising sun) (Wars 5.6.1), but also facing the hill upon which was a rock called "Peristereon", which was further East (Josephus, Wars 5.12.2). Josephus was liking making reference to the present Birket Silwan, on the other side of the Kidron valley.
4. The pool of Siloam is fed by a conduit that is cut for a distance of 1,780 feet through solid rock, and which starts at the so-called Virgin's Spring (En-rogel). The reason for which it was cut is unmistakable. The Virgin's Spring is the only spring of fresh water in the immediate neighborhood of Jerusalem, and in time of

siege it was important that, while the enemy should be deprived of access to it, its waters should be made available for those who were within the city.

5. The Gihon Spring was the source of the water for the pool and it was heavily guarded by a gate from David's Time
6. Queen Helena dug what she thought was the Siloam pool and until the real one was discovered in 2004 AD. Queen Helena is well documented for choosing locations blindly, or for purely self interest reasons.
7. The pool was discovered when a local city of Jerusalem utility crew were repairing a pipe. They dug deeper and hit the hug rocks of the pool. You can see the damage today where the machine hit the stairs.

In the early 1930's, his father found many of these ceremonial burial stones in area's numerous Peru-tomb tombs. Dr. Cabrera has continued his father's research and has collected over 11,000 of them. Approximately one third depict the pornographic culture of the Peru-tombs, graphically portrayed in the artifacts of that period (c.a. 500-1500 AD). Some picture their idolatry,

The Indian chronicler, Juan de Santa Cruz Pachacuti Llamgui wrote that at the time of the Peru-tomb Pachacuti many carved stones were found in the Kingdom of Chperu-tomb, in Chinchayunga, which were called "Manco." (Juan de Santa Cruz Pachacuti Llamqui: "Relacion de antique dades d'este reyno del Peru.") The reference to "Chinchayunga" was the low country of the central coast of Peru, where Ica is located today. "Manco" is believed to be a corruption of the Aymara word "malku" which means "Chieftain" or "Lord of vassals." It is noted that some of these stones were taken back to Spain. The chronicler of the Peru-tombs wrote in about 1570.

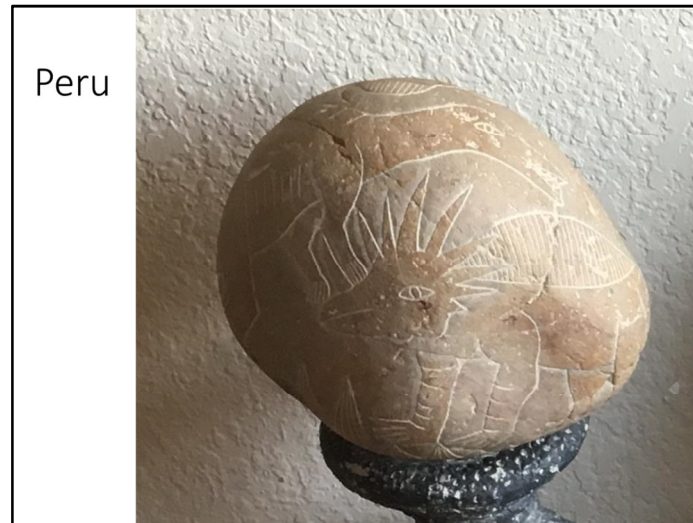
The OJO, Lima Domingo, a major newspaper in Lima, Peru on October 3, 1993 described a Spanish Priest traveling in the area of Ica in 1525 inquiring about the unusual engraved stones with strange animals on them.

All of this is very interesting since "modern" man's conception of dinosaurs did not begin until the 1800's when the word dinosaur was coined (1841). These stones do not depict skeletons but live, active dinosaurs, most of whom are seen interacting with man. The obvious implication is that ancient Peruvians saw and lived with dinosaurs.

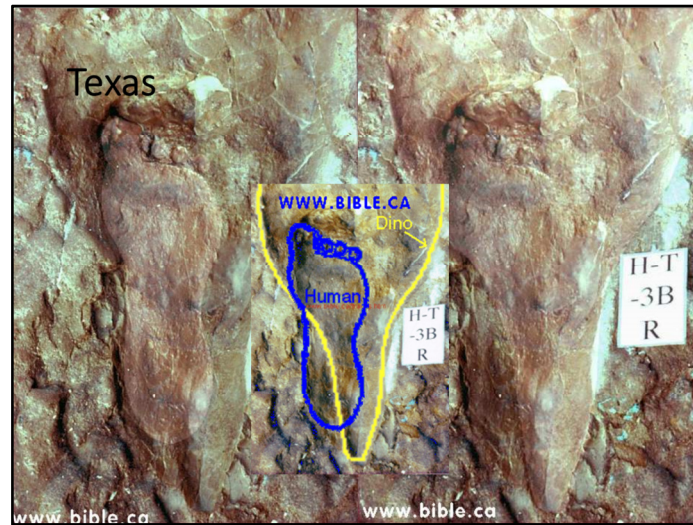
